## Deck the Halls

Delta Bingo is proposing to open a hall in Rockwood Mall, according to notices in the Mississauga News. According to the Councillor's office, the city is not aware of any such proposal. That being said, the notice



says to have any comments delivered to unnamed individuals, in unknown positions or departments at both City Hall and Queens Park not later than December 16.

Technically, Delta is asking to move from their current industrial location on Mattawa Ave. (off Dundas, across from The Brick). Their target location is in a mall in a residential area: our neighbourhood, our Rockwood Mall.

This is the perfect location for a Bingo Hall. Rockwood has a large senior population, many within walking distance, a relatively safe area with lots of parking and transit options. The Mattawa Avenue location needs a facelift, but otherwise, there are no problems, no liquor licence and no

slot machines--just Bingo. It is a place where local charities take an active part in the operation and in return earn money to fund their causes. Some of the charities include hockey clubs, the Knights of Columbus, women's shelters and the arts. Even the RHA, as a not-for-profit association, could be a charity partner.

Delta Bingo and Gaming currently operates many halls in the province. Many of their halls offer another form of gaming – slot machines. Along with the slot machines most serve alcohol. Over time, as the profits from the machines appears to be higher, the overall space allotted to Bingo shrinks to allow for more slot machines. As OLG runs the slot business, we can assume that this money is not shared with the local charities, or at least not in the same manner as with the Bingo profits. However, in the case of the Rockwood Mall location, the now vacant Rona property, is relatively small compared to other facilities.

Therefore, the option for slots may not be viable. Unfortunately, we have not continued on page 3



## Is Building Homes *Faster* the answer to our Housing Crisis?

When the Ontario government initiated the affordable housing initiative, who would have thought that it would lead in part to blowing up decades of municipal planning, environmental goals, and the belief that Joe citizen might have a say in what happens in his neighbourhood. With the passage of Bill 23, or "The

More Homes Built Faster Act, 2022" everything we once knew about: zoning and the right to appeal; community benefits; protection of Heritage properties;



Bill 23 promises to create 150,000 new homes per year for 10 years. It does not identify what type of homes they will be, what price or where they will be built. Will they be built on what we currently consider greenbelts or conservation property? Will they be compatible with the communities we expect with sufficient parkland and services or will the need to crank out cookie cutter properties at the rate required supersede the planning objectives of towns and cities? How

will this effect our neighbourhood, our schools and our greenspaces?

Yes, we need more housing. More housing will offer far more choices for those prepared to move away from the major markets where jobs are more plentiful. While the land may cost less, the cost of materials and labour will not. So, what is the real saving

if you consider the cost to commute? Yes, encouraging secondary units will help many afford to either stay in their homes or allow those just entering the market afford to purchase. But there is a significant

cost to renovating a property to add a second or third unit, particularly if it is on top of the million-dollar plus investment to purchase. Lenders would also have to amend their terms to make this feasible.

Cutting red tape, making it easier to get projects started is a good thing. Encouraging young people to enter the trades is good thing. Blowing up the standards set over the years, based on best practices and the input of the citizens, is not.

We encourage you to review one of the many articles on Bill 23 that outlines the effect that "The More Homes Built Faster Act, 2022" will have on housing, our environment and our communities. IW

seen the proposal, and until we do, we can only make suppositions as to the intended use.

The potential for slot machines in our mall is a concern. A relatively ugly secret is that the Dixie/Bloor community has the highest social risk index in all of Peel Region. Most halls that offer slot gaming stay open well after midnight, which is much later than the Bingo games end. Allowing slot gaming would make our neighbourhood vulnerable to potentially undesirable exposure during the early morning hours. Allowing the hall on Mattawa Avenue to move to Rockwood with the existing restriction (just Bingo) would be a source of entertainment for the community.

This could even be considered the adult version of Chuck E. Cheese with benefits to some local charities. However, allowing anything more than this should be considered a potential risk. If the Council feels that Pot Shops should not be a part of our neighbourhood, certainly they will agree that we should not have slot gaming in them either.

We will be sending an eblast to our mailing list in early December with a survey. The results will be tabulated and sent to the two office locations provided. The question is, do we want a Bingo Hall in Rockwood and if so, should it be with or without restrictions? 

### **Speed Cameras Coming Soon!**

Councillor Fonseca has come through with a promise to install speed cameras (ASE – Automatic Speed Enforcement) on Bough Beeches in the area of Sts. Martha and Mary School. Signs have now been posted announcing their pending arrival. Fines for those who speed will be significant.

Speed in the vicinity of a school is now 30 km/hr. in Mississauga. As a designated residential area all other streets in the neighbourhood, except where posted otherwise, is 40 km/hr.

### More or Affordable Housing?

On October 21, 2022, an information meeting regarding Affordable Housing Issues was held at the office of Sheref Sabawy, MPP for Mississauga.

The meeting was attended by Michael Parsa, Associate Minister of Housing and David Uveges, Director of Policy, Ministry of Housing and Kaleed Rasheed, Minister of Public and Business Services and MPP for Mississauga East Cooksville. Community members, including a representative from the RHA, had been invited to provide input based on their concerns

The following significant points were noted:

- There is a current shortage of housing in Ontario
- •The Ontario Government has committed to build 1.5 million homes over the next 10 years.
- •There is too much existing governmental red tape that slows the process of building houses/condos, etc.
- There is a dire shortage of skilled trades people
- · Materials to build housing are in short supply.

The Ontario government hopes that by allowing garage conversions, garden suites, laneway suites, and plexes, including duplexes and triplexes in already established communities will aid in providing more affordable housing. Resident groups represented at this meeting insisted

that, before giving carte blanche to conversions, consideration must be given to the current infrastructure of roads, parking, schools, libraries, etc.

The Province has introduced *Bill 23 "More Homes Built Faster Act."* The City of Mississauga staff have reviewed the Bill and have prepared their corporate report outlining how the Bill would impact the City of Mississauga. City Council reviewed the City report on November 23, 2022. Details were not available at time of this printing. W The Province is accepting comments from members of the public on the proposed changes until December 9, 2022. ## Runway 06L/24R is reopened!

In April 2022, Toronto Pearson temporarily closed east/west runway 06L/24R, the airport's second-busiest runway, for a full rehabilitation. This project is one of the largest runway repair projects in the airport's history.

The rehabilitation is now complete, on time, and on budget.

This project, funded in part by the federal government's Airport Critical Infrastructure Program, has extended the life of the runway by about 30 years and enhances Toronto Pearson's role in supporting a strong region, strong province, and strong Canada.
