Coyote Awareness 🕅 mississauga

With increased sighting of Coyotes and the approaching mating season, Councillors Fonseca, Damerla and Dasko arranged an information session on February 15th at the Burnhamthorpe Community Centre. Mississauga Animal Services presented information on coyote behaviour, the mating season safety tips and how to report coyote sightings.

To be clear, Coyotes are part of our neighbourhood and the objective is to coexist with them. They will not be removed unless they are sick or injured (in which case they will be returned when recovered) or they exhibit a real threat of injury to residents (they attach someone). The recommendation to live peacefully together: if you don't bother them, they will not bother us. In order to achieve this goal, residents should avoid approaching, harassing and otherwise interacting with coyotes such as approaching they dens or pups.

One of the best ways to reduce the coyote population is to remove their source of food. It goes without saying: DO NOT FEED the coyotes or for that matter any other critters such as squirrels or birds. Bird seed and bread crusts attract rats. RW

It takes a **Village**

While we are often disappointed when our efforts fail in dealing with the city, but this time it was different. By organizing resources and working together, the community worked as a team to bring attention to the fact that a minor variance could have a major impact on our neighbourhood. If you are not on our subscription list, you may not have heard of this tale. For those who know of the story, there is a surprise ending we did not previously share.

In November 2023, we started receiving emails from residents who were concerned that a neighbour had applied for a minor variance that could significantly affect our community. The variance was to change the zoning from single family residence to allow for "transient housing" or a halfway house on Rowntree Court.

The request for this variance did not include any indication of the type of "transitional housing" intended for the property. However, if passed, even for a benign purpose, such as a home for battered women, the reality is that once passed, the property could be used to house rehabilitating drug addicts, parolees (which could include sex offenders and child molesters), and other offenders being released into the community. Many of these halfway homes operate on a for-profit basis.

As this property abuts Sts. Martha and Mary school yard and is within 50 ft. of the walkway that accesses the school, there was a real concern for all children who attend the school or use the access from Rowntree Court. In the interest of protecting our children from potential danger, the RHA supported the residents of Rowntree Court to oppose this variance along with the school board and the parents of children attending the Sts. Martha and Mary school.

While Councillor Fonseca was required to stay at arm's length from the committee meeting, she did send a letter, on behalf of the residents to the Committee of Adjustments, and provided some insight on how we should proceed to achieve results: using a Cityapproved petition and encouraging an email campaign to the Committee of Adjustments stating the reasons for them to deny the variance. The major reason, other than the logical ones, was that a request to change the zoning was not a "minor" variance. Cathy Corsetti, a resident of Rowntree Court, who was the spokesperson for the residents, spearheaded a petition that collected 650 names and through our email base and the parents of Sts. Martha and Mary School, 130 emails were sent to the COA.

This matter was brought to the Committee of Adjustments on December 14, at which time they were to hear arguments for and against the variance before approving or dismissing the application. All correspondence was put into the record and several community members attended the meeting in person while many others were online, ready to speak for our community.

Without uttering a word, the application for the variance on Rowntree was denied. Long story short, the same agent was requesting a variance on another property for the same purpose and it was denied. Since our issues had already been addressed, the decision was already made. While there did not seem to be anyone questioning the other variance, it would appear that the members of the committee had in fact reviewed our information, and acted on the easier one first. The committee agreed that this was not a minor variance and is a matter for the Planners to consider. The Committee of Adjustments felt, as did we, that the whole transitional housing issue needs to be reviewed. They appeared to agree with the fact that changing the zoning would be perilous.

Hold the high fives, this story is not over. In January, we received notice that the applicant had appealed to the OLT (Ontario Land Tribunal) as is their right. We were assured that all the materials sent to the Committee of Adjustments along with their decision would be forwarded to the OLT at which point they would assess whether or not they would hear the appeal. If the OLT agrees to the appeal, the original participants, at least 20 on the speakers' list would have their say. The time frame for hearing an appeal would be approximately six months.

During this whole process, something did not feel right. The petitioner was not the

owner of the property, but in fact a tenant. The tenant is also a charity. The name of the owner never appeared on the application; however, it was known that the owner wanted to use this very upscale executive home as an Airbnb, had offered it for sale and finally rented it.

Whether this played any part of the decision or not, the appeal was withdrawn in early February, much to our delight. But the moral of the story is success as the result of team work. Yes, it took a village, our village to make this happen.

The Rockwood Residents' Association is here to help.

Furnace need replacing? Here is something to consider...

You can cut heating-related climate pollution by swapping out a gasfired furnace for an efficient, all-electric heat pump. Heat pumps are a more environmentally friendly heating. Current thinking is that switching to a renewable, low carbon air source heat pump is one of the biggest single actions one can take towards climate change.

Did you know that heat pumps can reduce a home's carbon footprint by up to 65% compared with heating your home with a gas boiler?

In addition, a heat pump system is three times more efficient than a gas boiler and also helps cut down on fossil fuel emissions, since heat pumps rely on electricity instead of burning fuels like propane and natural gas. The average life expectancy for heat pumps is normally 15 years. Heat pumps need twice annually tune ups (spring and fall) to maintain proper performance and energy efficiency. While these are great reasons to consider heat pumps, the reality is that heat pumps are powered by electricity which is more expensive and less plentiful.


